
COMMUNICATING THE ROLE OF THE TITLE IX HEARING

- Required by 2020 Title IX Regulations, as well as certain federal court decisions and state law
- Best practice for due process
- Permits full development of facts for independent decision-maker
- Permits decision-maker to assess credibility live
- More formal than most educational misconduct hearings, but should not be as formal as a judicial procedure

CURRENT REQUIREMENTS

- Live hearing
- Independent decision-maker
- Parties guaranteed advisors
- Advisors have opportunity to cross-examine other parties and witnesses
- Respondent can observe cross-examination of Complainant
- Parties may be in separate locations
- Must be recorded written, audio, or audiovisual

THE TITLE IX PROCESS



HEARING PROCESS

- Identification of hearing officer(s) and scheduling
- Hearing notice
- Pre-hearing conferences with each party and their advisor
- Hearing, including party statements and questioning of parties/witnesses from hearing officer(s) and advisors
- Conclusion of hearing
- Analysis of relevant evidence, credibility, and policy standards by hearing officer(s)
- Possible consultation with administrators on sanctioning
- Issuance of written determination to parties and advisors
- Appeal opportunity
- If no appeal, written determination finalized

IDENTIFYING HEARING PERSONNEL

- Hearing Facilitator: Coordinates logistics and communication
 - Usually Title IX Coordinator or Title IX administrative personnel
 - Internal liaison for external resources
 - Procedures must follow institutional policies and federal and state law
- Decision-Maker(s): Leads hearing procedures and renders determination
 - Internal or external
 - Individual or panel
 - Must be familiar with institutional policies and federal and state law
- Advisors: Support parties and conduct questioning
 - Parties must be permitted to use the advisors of their choosing
 - Internal or external
 - Should be comfortable with questioning/cross-examination procedures and best practices
- Support People: Emotional support for parties
 - May be allowed according to your policy
 - Internal or external
 - May be assigned or chosen

HOW STUDENT AFFAIRS CAN PREPARE STUDENTS FOR THE HEARING

- Ensure parties have an advisor with whom they are comfortable
- Ensure parties have a support person if permitted, and/or a support network
- Connect to resources and implement accommodations
- Secure private and comfortable space for hearing
- Answer all questions, or direct questions to the Title IX Coordinator
- Paint a clear picture about what to expect
 - Who will be present
 - Setting and technology
 - What questioning will be like
 - Questions they might receive
 - Timeline for before, during, and after the hearing
- Remember to treat all parties and witnesses equally!

POST-HEARING SUPPORT

- Even when the matter is concluded, it is important to continue providing support
- One (or both) parties will probably not be satisfied with the outcome
- The hearing may trigger negative mental and emotional responses for participants
- Ensure everyone impacted is connected to needed services
- Be transparent, clear, and honest about next steps and moving forward
- Be available for future assistance it might take time for someone to realize what they need

SETTING EXPECTATIONS ON THE ANTICIPATED REGULATIONS

- New federal Title IX regulations expected in 2023
- Hearing requirement may be eliminated
- Institutions may have discretion to determine whether they will hold live hearings or opt for meetings between the decision-maker(s) and parties to assess credibility, considering:
 - Campus culture
 - Available resources
 - Prior and potential litigation
 - Practices that have/haven't worked well under the 2020 regulations
 - Due process
 - Impact on parties
- In the circuits and states that have made live hearings mandatory, institutions will have to continue holding hearings
