### Clery Act Background

1

Enacted in 1990 as Crime Awareness and Campus Security Act of 1990

Numerous amendments

02

1998 amendment renamed law to Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act ("Clery Act") in memory of Jeanne Clery

2013 – VAWA Act included amendments to Clery Act

#### CLERY ACT REQUIREMENTS

01	Annual security report
02	Crime statistics
03	Timely warnings and emergency notifications
04	Crime log
05	Emergency response and evacuation procedures
06	Missing student notification policies and procedures
07	Programs to prevent dating violence, domestic violence, sexual assault, & stalking
08	Procedures for institutional disciplinary action in cases of alleged dating violence, domestic violence, sexual assault, or stalking







Enforced by the Department of Education's Office of Federal Student Aid



Maximum fine per violation = \$69,733



Department of Education, Office of Postsecondary Education, has published several iterations of a handbook as a tool to assist in complying with Clery Act



The Handbook for Campus Safety and Security Reporting, 2016 Edition - rescinded in 2020



Replaced with new appendix to Financial Student Aid Handbook -Clery Act Appendix for FSA Handbook
